

MARK E. RECKTENWALD Chief Justice, Supreme Court of Hawai'i

Representative Linda Ichiyama is a member of the Hawai'i House of Representatives, elected in 2010 to represent District 32 (Moanalua, Salt Lake, and Aliamanu). She serves as the Chair of the House Pandemic & Disaster Preparedness Committee. Ichiyama is one of the co-conveners of the Women's Legislative Caucus as well as a member of the House Committees on Government Reform and Judiciary & Hawaiian Affairs.

Chief Justice Mark E. Recktenwald currently serves as the Chief Justice of the Supreme Court of Hawai'i. He first became an Associate Justice on May 11, 2009 and was later appointed as the Chief Justice on September 14, 2010. Prior to his appointment to the Hawai'i Supreme Court, Chief Justice Recktenwald served as the Chief Judge of the Hawai'i Intermediate Court of Appeals and as an Assistant United States Attorney for the District of Hawai'i.
