- Ralph A. Acampora is Assistant Professor in the Department of Philosophy and Religion, Hofstra University, Bangor, Maine. His research interests are in environmental philosophy, including ecosophy and bioethics, especially inter-species morality, as well as in the history of philosophy, the moderns (Hume and Nietzsche) and ethnophilosophy.
- Muthiah Alagappa, Director of Studies at the East-West Center, is a member of the editorial board of *The Pacific Review* and *The Australian Journal of International Affairs*. He is also on the Research Council of the International Forum for Democratic Studies, and on the editorial committee of the East-West Center book series, "Contemporary Issues of the Asia-Pacific." His publications include Asian Security Practice: Material and Ideational Influences; Systemic Change, Security, and Governance in the Asia-Pacific Region; The New Asia-Pacific Order; Regional Institutions, The United Nations, and International Security; and Political Legitimacy in Southeast Asia: The Quest for Moral Authority.
- Syed Muhammad Naquib Al-Attas is Founder-Director of the International Institute of Islamic Thought and Civilization, Kuala Lumpur, and Professor at the National University of Malaysia. He has written more than twenty books on Islam. For his outstanding contributions in the field of philosophy, he was named to the Distinguished Al-Ghazali Chair of Islamic Thought, and made a Fellow of the Imperial Iranian Academy of Philosophy and a Member of the Royal Academy of Jordan. He has also received an Honorary Doctorate of Arts from the University of Khartoum.
- Tamara Albertini, Associate Professor of Philosophy at the University of Hawai'i, has published two books in the field of Renaissance philosophy: Verum et Factum: Beiträge zur Geistesgeschichte und Philosophie der Renaissance and Marsilio Ficino: Die Vermittlung von Denken und Welt in einer Metaphysik der Einfachheit. She is currently working on a monograph of Charles de Bovelles and on a book in Islamic philosophy that considers Muslim intellectual contributions from Andalusia to Central Asia.
- Roger T. Ames is Professor of Philosophy and Director of the Center for Chinese Studies at the University of Hawai'i. He is editor of Philosophy East & West and China Review International. His recent publications include translations of Chinese classics: Sun-tzu: The Art of Warfare; Sun Pin: The Art of Warfare, and Tracing Dao to Its Source (both with D. C. Lau); and Confucian Analects (with H. Rosemont). He has also co-authored with David Hall interpretive studies of Chinese philosophy and culture: Thinking Through Confucius; Anticipating China: Thinking Through the Narratives of Chinese and Western Culture; and Thinking from the Han: Self, Truth, and Transcendence in Chinese and Western Culture.
- Wayne D. Andrews is Associate Professor of Philosophy at Hawai'i Pacific University. His 1988 dissertation was *Interests: The Deontological Conception and the Teleological Conception.*" His areas of research specialization are in applied ethics and ethical theory.
- Yoko Arisaka is Assistant Professor of Philosophy at the University of San Francisco. She has published articles in modern Japanese philosophy, phenomenology, feminism, and political philosophy. She is co-editor of the forthcoming anthology *Nishida and the Problem of Modernity*, and is currently working on a manuscript for a book to be titled *Philosophy and Imperialism: Asian Modernism in Prewar Japan*.
- Earl Bakken, developer of the pacemaker and Chair of the Board of the North Hawai'i Community Hospital, was co-founder of Medtronic, Inc., a leading medical technology

- company. At the Community Hospital, he has fostered the fusion of alternative and traditional therapy. His vision for the Big Island is as a holistic place with a unique blend of Western and complementary medicine. He has Doctor of Science degrees from three universities and has received numerous awards, including a Gold Medal from the European Society of Cardiology and the Living Treasure of Hawai'i Award.
- Michael Barnhart is Associate Professor of Philosophy at Kingsborough Community College of the City University of New York. He is currently finishing an edited collection, *Varieties of Ethical Reflection*, and is beginning work on another book comparing Confucian and Buddhist models of democracy. He also edits the *SACP Forum*, the Society for Asian and Comparative Philosophy newsletter.
- David Batstone, Associate Professor of Theology and Religious Studies, University of San Francisco, is also Executive Editor at Sojourners, a media communications company that promotes values and ethics at the crossroads where spirituality, politics and culture meet. Among his recent publications, he authored and edited From Conquest to Struggle: Jesus of Nazareth in Latin America; New Visions for the Americas: Religious Engagement and Social Transformation and The Good Citizen (with Eduardo Mendieta). He has been guest editor for the journals Peace Review and Sojourners.
- Carl Becker is Professor and Department Chair at Kyoto University. He has an Honorary D.Litt. from the International University of Bombay. Currently he is working under Japanese government grants to develop "more genuinely Japanese terminal care." The author of 13 books, mostly published in Japan, his main publications include *Breaking the Circle: Death and Afterlife in Buddhism; Communication: East and West*, and Cases and Activities in Politics and Economics (co-authored).
- Jerry H. Bentley is Professor of History at the University of Hawai'i and editor of Journal of World History. His research on the religious, moral, and political writings of Renaissance humanists led to the publication of Humanists and Holy Writ: New Testament Scholarship in the Renaissance and Politics and Culture in Renaissance Naples. His recent research has concentrated on global history and on processes of cross-cultural interaction, resulting in the book Old World Encounters: Cross-Cultural Contacts and Exchanges in Pre-Modern Times and a pamphlet, Shapes of World History in Twentieth-Century Scholarship.
- Eric Blondel is Professor of Philosophical Ethics at the Université de Paris I-Panthéon-Sorbonne. His publications include, among others, *Nietzsche, le "Cinquième Évangile"?*; *Le Risible at le Dérisoire; L'Amour*; and *La Morale*, as well as various essays in international philosophical reviews.
- Paul Richard Blum is Professor of Philosophy at Peter Pazmany University in Budapest, Hungary. He has published a number of books on Renaissance philosophy and on the scholastic tradition in modern times. His most recent books are a comprehensive study on Giordano Bruno and a textbook on philosophers of the Renaissance.
- Ignasi Boada received his Ph.D. in philosophy at the Autonomous University of Barcelona. His thesis is entitled *The Development of Hegel's Concepts of Finitude and Infinitude from 1795 to 1801*. Since 1994, he has been participating in the Research Group of *Vivarium Academicum*, Centre of Intercultural Studies.
- Gernot Böhme has been Professor of Philosophy at the Technical Unversity of Darmstadt since 1977. He is Speaker of the Graduate College, Technologization and Society. His publications include, among others, Finalization in Science: The Social Orientation of Scientific Progress; Coping with Science; and Für eine Ökologische Naturästhetik.

- Ron Bontekoe is Associate Professor and Graduate Chair in the Department of Philosophy, University of Hawai'i. He is the author of *Dimensions of the Hermeneutic Circle* and coeditor of *Justice and Democracy: Cross-Cultural Perpectives* (with Marietta Stepaniants) and *Companion to World Philosophies* (with Eliot Deutsch). He is currently working on a book on pragmatic idealism that aims to delineate the conditions that govern and define the limits of social, cultural, moral, and scientific progress.
- Francesca Bray is Professor of Anthropology at the University of California, Santa Barbara. She has published the volume on agriculture in Needham's series, Science and Civilisation in China; The Rice Economies: Technology and Development in Asian Societies; and her latest book is Technology and Gender: Fabrics of Power in Late Imperial China. Her current project explores the political, social, and cultural dimensions of everyday technologies in contemporary California.
- Steven T. Brown is Assistant Professor of Japanese in the East Asian Languages and Literatures Department, University of Oregon. He is currently working on Theatricalities of Power: The Cultural Politics of Noh Drama; Witnesses to Chance: Philosophical Negotiations with Contingency; and Tokyo Cyberpunk: Machinic Desires, Cyborg Dreams, and Dystopic Cities in Japanese Anime.
- Conrad Brunk is Academic Dean and Professor of Philosophy at Conrad Grebel College, University of Waterloo, Ontario. He is co-author of *Value Assumptions in Risk Assessment* and author of many articles in journals and books on ethical issues in technology and the environment. He is a consultant to the Canadian government departments and the United Nations on agricultural risk management.
- James Buchanan is the Caroline Werner Gannet Professor in Humanities at the Rochester Institute of Technology. He has lectured and consulted on comparative value systems and the challenges of being moral in an age dominated by technology. He was on the original planning committee for the Parliament of the Worlds' Religions and negotiator at the United Nations Earth Summit (in biotechnology). His publications include Changing Nature's Course: The Ethical Challenges of Biotechnology and the forthcoming two-volume The Myths of Understanding: Power and Worldviews and The Information Age: Ethics in an Age of Globalization.
- Elizabeth Buck, Director of Education at the East-West Center, is co-director of the Asian Studies Development Program, a joint program of the East-West Center and University of Hawai'i designed to expand teaching about Asia at U.S. community colleges and state universities. She is the author of *Paradise Remade: The Politics of History and Culture in Hawai'i.*
- John Bussanich is Professor of Philosophy and Religious Studies and Head of the Department of Philosophy and Religion, James Madison University, Virginia. He is the author of *The One and Its Relation to Intellect in Plotinus: A Commentary on Selected Texts* and the forthcoming *Philosophy in Late Antiquity.* In progress is *Mystical Dimensions of Greek Philosophy.* He is also co-editor of the journal *Ancient Philosophy.*
- William A. Callahan is a Lecturer of East Asian International Relations in the Politics
 Department at the University of Durham, England. His current research examines the interaction of culture and international relations, specifically how Chinese civilization shapes regional politics. His publications include *Imagining Democracy: Reading the "Events of May" in Thailand* and *Pollwatching, Elections, and Civil Society in Southeast Asia* (in press).
- Arindam Chakrabarti, Professor of Philosophy at the University of Hawai'i, was a professor in the Department of Philosophy at the University of Delhi before coming to the University of Hawai'i in 1997. He is the author of *Mane Bishoyok Darshonik Shamoshya*, in Bengali, on the

- theory of meaning, and *Denying Existence*. He also edited *Knowing from Words*, with Bimal Matilal. He is currently working on a book on moral psychology.
- Jonathan Chan is Assistant Professor in the Religion and Philosophy Department of Hong Kong Baptist University and a research fellow at the university's Centre for Applied Ethics. He was recently invited to contribute a lead paper on "Institutional Global Ethics: Applications" for an encyclopedia of environmental ethics. He is also a contributor for a volume in the Philosophy and Medicine series.
- Wing-cheuk Chan, Associate Professor in the Department of Philosophy, Brock University, Canada, was formerly a Humboldt Fellow. His publications include *Heidegger and Chinese Philosophy* and *Modernity and Post-Modernity* (in Chinese).
- David W. Chappell is Professor of Buddhism and Chinese religions and Graduate Chair of the Department of Religion at the University of Hawai'i. His publications include *T'ien-t'ai Buddhism: An Outline of the Fourfold Teachings* (translator and editor) and *Buddhist-Taoist Studies I* and *II* (editor). He is also founding editor of the *Buddhist-Christian Studies Journal*.
- Chung-ying Cheng, Professor of Philosophy, University of Hawai'i, and editor, Journal of Chinese Philosophy, is the founder and past president of the International Society of Chinese Philosophy, and founder and president of the International Society for Yijing Studies. He has received an honorary doctorate from the Far Eastern Institute of the Russian Academy of Sciences. He has authored and edited 15 books, including Chinese Culture: Its Modernization and Globalization; New Dimensions of Confucian/Neo-Confucian Philosophy; Philosophy at the Crossing of Centuries: Interpretation and Integration; and On the Spirit of Philosophy in China and the West.
- Scott Clark is Associate Professor of Anthropology at Rose-Hulman Institute of Technology, Terre Haute, Indiana. Currently he is a Fulbright Researcher studying engineering ethics in Japan. His professional interests are trans-cultural training, technology and society, cultural anthropology, and culture change.
- Gary Comstock, Coordinator and Associate Professor in the Bioethics Program, Department of Philosophy and Religious Studies, Iowa State University, has published more than 50 articles and book chapters in life science ethics and philosophy of religion. He edited *Is There A Moral Obligation to Save the Family Farm?*, compiled *Religious Autobiographies*, and is editing *Beyond Bioethics*, a forthcoming volume of essays.
- Harold Coward is Professor of History and Director of the Centre for Studies in Religion and Society at the University of Victoria, Canada. He has recently directed several interdisciplinary team studies in the areas of environment and health care ethics, in which both religious and secular ethics are applied to contemporary issues. For his work, he recently received an honorary doctorate from the University of Alberta.
- Sean Cridland, Assistant Professor of Political Science and Philosophy at Fort Lewis College, Colorado, received his Ph.D. from the University of Hawai'i. His dissertation, Of Nomads and Nothingness: An Ecology of Self and Other, was a look at the origins of culture through a comparison of French Existential, Japanese Zen Buddhist, and Post-modern Nomadic notions of nothingness.
- Cromwell Crawford, Professor at the University of Hawai'i, teaches Comparative Ethics, Religion and Medicine, and Indian Studies. He is also on the Governing Council of the World Association for Vedic Studies. His publications include In Search of Hinduism; World Religions and Global Ethics; Dilemmas of Life and Death: Hindu Ethics in a North American Context; and the forthcoming Hindu Bioethics for the Twenty-first Century.

- Fred Dallmayr is Packey J. Dee Professor of Political Theory at the University of Notre Dame. Among his publications are Margins of Political Discourse; Life-World, Modernity, and Critique; Beyond Orientalism: Essays on Cross-Cultural Encounter; and Alternative Visions: Paths in the Global Village as well as numerous journal articles. He was recently appointed General Editor of a new series, Global Encounters: Studies in Comparative Political Theory, and he edited its first volume, Border Crossings: Toward a Comparative Political Theory.
- Vrinda Dalmiya, Assistant Professor of Philosophy at the University of Hawai'i, was at the Indian Institute of Technology, Delhi, before coming to Hawai'i. She has published in a number of journals and is currently working on several projects within areas of epistemology and feminist philosophy.
- Barbara Darling-Smith has served as Assistant Director of Boston University's Institute for Philosophy and Religion since 1992, and is also Assistant Professor of Religion at Wheaton College, Massachusetts, where she was selected as "Teacher of the Year" in 1996. She edited Can Virtue Be Taught? and has published essays and reviews on comparative religion and ethics.
- Frank W. Derringh is Associate Professor of Philosophy, Social Science Department, New York City Technical College. He received his Ph.D. from Columbia University in 1980 and his main research interests are environmental philosophy and green political thinking.
- Giri Deshingkar is Director of the Centre for the Study of Developing Societies, New Delhi, as well as the Institute of Chinese Studies. He is also Co-ordinator of the Institute of Peace and Conflict Studies. After completing his diploma in Electronic Engineering, he switched his field of studies to Chinese language and went on to specialize in Chinese history. He has published on subjects relating to Chinese history, politics, and foreign relations. He recently completed a monograph, *The People's Liberation Army: On the Road of Modernization*.
- Eliot Deutsch, Professor and Chair of the Department of Philosophy, University of Hawai'i, is past president of the Society for Asian and Comparative Philosophy and past editor of *Philosophy East and West*. He was also Director of the Sixth East-West Philosophers' Conference. He has authored and edited 16 books including, among the most recent, *Religion and Spirituality; Essays on the Nature of Art; Introduction to World Philosophies;* and *A Companion to World Philosophies.* His work has been translated into French, Russian, Chinese, Korean, Italian, Japanese, and Spanish. He is currently developing a pluralistic cross-cultural theory of rationality.
- Rolf Elberfeld is Assistant Professor at the University of Wuppertal, Germany. He is the author of Kitaro Nishida: Moderne Japanische Philosophie und die Frage nach der Interkulturalitt and Denkanstze zur Buddhistischen Philosophie in China: Seng Zhao-Fazang-Jizang Zwischen Bersetzung und Interpretation (with M. Leibold and M. Obert). He also co-edited Komparative Philosophie: Begegnungen Zwischen Ostlichen und Westlichen Denkwegen.
- George R. Ellis, President and Director of the Honolulu Academy of Arts since 1982, was formerly at the UCLA Museum of Cultural History. He was named Hawai'i Salesman of the Year in 1996 in recognition of his support for, and promotion of, Hawaii's cultural attractions. He is active on many boards including Hawai'i Pacific University's Humanities Advisory Committee and Kapi'olani Community College's Art Advisory Board. Dr. Ellis has also served as a juror for statewide art shows and as consultant to the State Foundation on Culture and Art.
- Carl W. Ernst is Professor and Chair, Department of Religious Studies, University of North Carolina-Chapel Hill. His recent publications include Ruzbihan Baqli: Mystical Experience and the Rhetoric of Sainthood in Persian Sufism; Eternal Garden: Mysticism, History, and Poli-

- tics at a South Asian Sufi Center; Words of Ecstacy in Sufism, and The Shambhala Guide to Sufism.
- Charles Ess is Professor and Chair, Philosophy and Religion Department, Drury College, Missouri. He has published in ethics, computer resources for humanists, and computer-mediated communication. His book *Philosophical Perspectives on Computer-Mediated Communication* is used nationally and abroad as a textbook. He has received awards for teaching excellence and for his work in hypermedia.
- Andrew Feenberg is professor of Philosophy at San Diego State University. His publications include, among others, *Critical Theory of Technology; Alternative Modernity*; and *Questioning Technology*. Dr. Feenberg has written extensively on computer mediated communications. He is recognized as an early innovator in the field of online distance learning, a field he helped to create in 1981. He is currently working on "The Ethics of Virtual Community."
- Kathy E. Ferguson teaches feminist theory, political theory and related courses in Political Science and Women's Studies at the University of Hawai'i. Her two most recent books are Oh, Say, Can You See? The Semiotics of the Military in Hawai'i and Kibbutz Journal: Reflections on Gender, Race and Militarism in Israel. Her earlier books are The Man Question: Visions of the Subjectivity in Feminist Theory; Self, Society and Womankind: The Dialectic of Liberation; and The Feminist Case against Bureaucracy.
- Gregory P. Fields, Assistant Professor of Philosophy at Southern Illinois University at Edwardsville, specializes in comparative philosophy and religion as well as in South Asian and American Indian traditions. He is currently working on a manuscript, *American Indian Philosophy: Readings, Commentaries, and Critical Essays.*
- Jun Fudano is a Professor of History of Science and Technology at the Kanazawa Institute of Technology. He was a Graduate Fellow at the Smithsonian's National Museum of American History before joining the faculty of KIT. His research interests include the history of science and technology, ethical issues in science and engineering, and the institutional history of U.S. and Japanese universities.
- Jane M. Geaney is Assistant Professor of Religion, University of Richmond, and Co-Chair of the Chinese Religions Group for the American Academy of Religion. Her dissertation was Language and Sense Discrimination in Early China and she has a book under consideration for the University of Hawaii's "Monograph Series in Asian and Comparative Philosophy."
- Norman Geschwind is Associate Professor of History at Hawai'i Pacific University and a Visiting Fellow at the East-West Center where he is writing a book on the historical origins of the Center. He has introduced a history of science course at HPU and is currently also teaching World Civilization and Environmental Studies.
- James Giles is Acting Lecturer in Philosophy at the University of Copenhagen and Tutor at Madingley Hall, University of Cambridge. He is author of A Study in Phenomenalism and No Self to be Found: The Search for Personal Identity and editor of French Existentialism: Consciousness, Ethics, and Relations with Others and the forthcoming Kierkegaard and Freedom.
- Karen Gloy is Ordinary Professor for Philosophy and History of Ideas at the Institute for Philosophy, Faculty of Theology, later of Humanistics, at the University of Lucerne, Switzerland. She is co-editor of the magazine System der Philosophie. Her publications include, among others, Studien zur Theoretischen Philosophie Kants; Das Verständnis der Natur; and Bewußtseinstheorien: Zur Problematic und Problemgeschichte des Bewußtseins und Selbstbewußtseins.

- Susantha Goonatilake, former Senior Consultant for the United Nations on science and technology, is currently with the New School for Social Research, New York, as well as with Vidyartha Center for Science and Society, Colombo. He is the author of Technological Independence: The Asian Experience; Merged Evolution: The Long Term Implications of Information Technology and Biotechnology; and Toward a Global Science: Mining Civilizational Knowledge.
- Joseph Grange has been Professor of Philosophy at the University of Southern Maine since 1979. His publications include *The City: An Urban Cosmology* and *Nature: An Environmental Cosmology* as well as articles in philosophical journals. He is also editor of the forthcoming *Being and Dialectic: Metaphysics as a Cultural Presence.*
- David L. Hall is Professor of Philosophy at the University of Texas at El Paso. Among his works on the philosophy of culture and American philosophy are Eros and Irony—A Prelude to Philosophical Anarchism and Richard Rorty—Poet and Prophet of the New Pragmatism. He also authored a philosophical novel, The Arimaspian Eye. With Roger T. Ames he has published four books: Thinking Through Confucius; Anticipating China; Thinking from the Han; and The Democracy of the Dead—Dewey, Confucius, and the Hope for Democracy in China.
- Chaibong Hahm, Associate Professor in the Department of Political Science and Director of the Comparative Cultural Studies Center of the Institute of East and West Studies, Yonsei University, Korea, is also Editor-in-Chief of Jontong gua Hyundae. His publications include Postmodernity and Confucianism: In Search of a Korean Political Discourse and Korean Politics in the 21st Century.

Her dissertation was "Rationalizing Epistemology: An Argument Against Naturalism in Social Analyses of Knowledge."
- Lois Ann Lorentzen is Associate Professor in the Department of Theology and Religious Studies, University of San Francisco. She is the author of Eduardo Mendieta and Dwight Hopkins and has co-edited a number of books including Liberation Theologies, Postmodernity and the Americas and The Gendered New World Order: Militarism, the Environment and Development. She also serves as Associate Editor of Terra Nova: The Journal of Nature and Culture and Peace Review: The International Quarterly of World Peace.
- Kem Lowry is Professor and former Chair of the Department of Urban and Regional Planning and Director of the Program on Conflict Resolution, University of Hawai'i. He has published numerous articles on land use, coastal management, conflict resolution and evaluation.

- David Loy is Professor in the Faculty of International Studies, Bunkyo University, Chigasaki, Japan. His publications include *Nonduality: A Study in Comparative Philosophy* and *Life in Psychotherapy, Existentialism and Buddhism*. A student of Zen for many years, he is qualified as a *sensei* (teacher) in the Sanbo Kyodan lineage.
- Heinz C. Luegenbiehl is Head of the Department of Humanities and Social Sciences and Professor of Philosophy and Technology Studies at Rose-Hulman Institute of Technology, Terre Haute, Indiana. His areas of primary interest are professional ethics, phenomenology and existentialism, philosophy and technology, and philosophy of religion.

His current works in progress are a book on loneliness, and a systematic statement of his philosophy of religion. He has edited or co-authored 20 other books.

- Sharon Rowe has taught philosophy in Hawai'i for the past 20 years. Currently she holds a position at Kapi'olani Community College in addition to lecturing at the University of Hawai'i at Manoa. Her most recent work has been published in Asian Culture Quarterly and The Journal of Ritual Studies.
- V. Sanil teaches philosophy, including philosophy and film, at the Department of Humanities and Social Sciences, Indian Institute of Technology, New Delhi, India. He has published a number of articles in academic journals.
- Suwanna Satha-Anand, Associate Professor in the Department of Philosophy, Chulalongkorn University, Bangkok, has published six books in Thai and some 20 articles in Thai and English. Since 1996, she has been a consultant to the Commission for Peace and Justice, Thailand, and she was recently selected to join the Japan Foundation's Asia Leadership Fellows Program.
- Somei Satoh has written more than thirty compositions, including works for piano, orchestra, chamber music, choral and electronic music, theater pieces and music for traditional Japanese instruments. Satoh is one of six composers from around the world who have been asked to write works expressing their visions as part of a program of the New York Philharmonic Orchestra to be called "Messages for the Millennium."
- John Schroeder is Assistant Professor in the Department of Philosophy and Religious Studies, St. Mary's College of Maryland. He has several works in progress including *The Unsurpassed Medicine of Buddhism: Nāgārjuna and the Doctrine of "Skillful Means"* and *Philosophy of Sexuality: A Comparative Perspective* (edited).
- Margarita Schultz is Chair Professor, Faculty of Arts, University of Chile. She has been a Lecturer in Europe as well as South America and has published in international academic journals. She wrote and edited nine books including *The Epistemological Criticism in Art History; The Informatic Golem: Marks about the Aesthetics of Techno-Art;* and *The Power of the Word: Notes on Denomination and Creation* (co-edited).
- Asher Seidel is Associate Professor of Philosophy at Miami University, Ohio. His fields of specialization are metaphysics and philosophy of artificial intelligence. He has published in a number of journals including *Analysis*, *Linguistics and Philosophy*, *Philosophia*, and *Pacific Philosophical Quarterly*.
- Jean Seidengart, Professor of Philosophy at the University of Reims, has been Director of the Department of Philosophy since 1995. He is a founding member of the Internationale Ernst Cassirer-Gesellschaft in the Institute FEST of Heidelberg, Germany, and of the Centro Internazionale de Studi Bruniani in the Istituto Italiano per gli Studi Filosofici of Naples, Italy. His publications include the translations of Kant's Histoire Générale de la Nature et Théorie du Ciel; Giordano Bruno's De l'infinito, Universo e Mondi; and a forthcoming book, Histoire de l'idée d'infini dans la Cosmologie Classique.
- James D. Sellmann is Chairperson of the Division of Humanistic Studies and Associate Professor of Philosophy at the University of Guam. He is also a faculty member of the East Asian Studies program and the graduate program in Micronesian Studies. His book manuscript *Timing and Rulership in Master Lü's Spring and Autumn Annals is under review at SUNY Press.* He is currently working on *Philosophical Fragments of Master Shi*.
- Ramon Sentmartí, Senior Researcher in Public Perception of Agricultural Biotechnologies at the Autonomous University of Barcelona, Spain, is a founding member of Vivarium Academicum, Centre of Intercultural Studies, and member of the Association for the Study

- of Ethnicity and Nationalism. He is coordinator and editor of Classics del Nacionalisme and El Concepte de Politica a Inicis del Tercer Mileni.
- Dhirendra Sharma, former Chair of the Centre for Studies in Science Policy, Jawaharlal Nehru University, and President of the Indian Science Writers' Association, is founding editor of *Philosophy and Social Action* (quarterly). He is a leading anti-nuclear and civil rights campaigner. His major works include *India's Nuclear Estate; Scientific Knowledge and Social Imperatives;* and *India's Nuclear Dissent*.
- Kristin Shrader-Frechette is O'Neill Professor of Philosophy and Philosophy of Science and concurrent Professor of Biology at the University of Notre Dame. Past president of the Society for Philosophy and Technology and president of the Risk Assessment and Policy Association, she is also president of the International Society for Environmental Ethics. She has published more than 250 articles and 14 books/monographs including Environmental Ethics; Risk and Rationality; Technology and Human Values; and Nuclear Power and Public Policy: The Social and Ethical Problems of Fission Technology.
- Mark Siderits is a Professor in the Department of Philosophy, Illinois State University. He is the author of *Indian Philosophy of Language: Studies in Selected Issues* in the *Linguistics and Philosophy* monograph series. His areas of specialization are Indian philosophy and metaphysics.
- Ravindra Raj Singh chairs the Department of Philosophy, Brock University, Canada. He has published a number of articles in scholarly journals on Gandhi and Heidegger.
- Barbara B. Smith, founder of the Ethnomusicology program at the University of Hawai'i, is Professor Emerita of Music and a former Senior Fellow at the East-West Center. She has been a leader in educational programs to embrace local indigenous performing arts and contemporary compositions which incorporate Asian and Western elements. Her lecture-demonstration, "Electronics in Music" in the 1960 Festival of Music and Art of This Century, was the first presentation of this music in Honolulu. Her recent writings have been on Pacific Islands music for several major music encyclopedias.
- Vasanthi Srinivasan is Assistant Professor at Carleton University. Her research interests are contemporary continental philosophy, especially that of Habermas, and East-West dialogue in religion and philosophy.
- Marietta Stepaniants has been Professor and Director, Center for Oriental Philosophies Studies at the Institute of Philosophy, Russian Academy of Sciences, since 1980. She is also currently the chair of Oriental Philosophies at the Russian State University of Humanities. She is editor of more than 20 volumes and the author of ten books including Muslim Philosophy of the Nineteenth and Twentieth Centuries; Sufi Wisdom; and Introduction to Oriental Philosophy. Her writings were translated and published in eighteen countries. In 1995, Professor Stepaniants was Director of the Seventh East-West Philosophers' Conference.
- Vyacheslav S. Stiopin, an active member of the Russian Academy of Sciences, is Director of the Institute of Philosophy of the Russian Academy of Sciences and Chair of Philosophical Anthropology of the Moscow State Lomonosov University. He is one of the founders and directors of the Russian University for Humanitarian Education, which was formed as the first institution integrating academic science and high school. He authored more than 200 articles and 16 books (translated into many languages) including Scientific Picture of the World in the Culture of Technogenic Civilization; Philosophy of Science and Technics; and Age of Changes and Plots of Future. Recently, he was made Honorable Professor of Moscow State University and Doctor Emeritus of the Karlsruhe University, Germany.

- James A. Stroble is currently a lecturer at the University of Hawai'i, West Oahu, and Chaminade University of Honolulu. He is working on issues of political legitimacy of the use of force and deception in governing, using comparisons with ancient Chinese philosophy.
- Dylan Suzanne is a senior Ph.D candidate at Vanderbilt University where he is in the Ph.D. program. As a Teaching Assistant, his focus is on the ethics of technology, and his areas of specialization are contemporary philosophy of technology and applied ethics.
- Michele Svatos is Assistant Professor, Department of Philosophy, Iowa State University. Her 1994 dissertation was *The Foundation and Structure of Virtue Ethics*. Her current research areas are in ethical, jurisprudential, and public policy issues associated with the ownership of genetic resources and computer software, and also in ethical issues associated with risk.
- Margaret Leng Tan is an internationally celebrated artist whom *The New Yorker* has called "the diva of the avant-garde." She is renowned for her performances of American and Asian music that defy the piano's conventional boundaries. The first woman to graduate with a doctorate in music from the Juilliard School, she has since created a radically individual style fusing sound, choreography, theater and perfomance art. She has premiered works by many composers who have written for her, including John Cage and Somei Satoh.
- Noritoshi Tanida is Associate Professor at Hyogo College of Medicine, Nishinomiya, Japan. He recently authored *Textbook of Infectious Diseases* and published an article, "What Happened to Elderly People in the Great Hanshim Earthquake."
- Majid Tehranian is Professor of International Communication at the University of Hawai'i and Director, Toda Institute for Global Peace and Policy Research. His latest books are Technologies of Power: Information Machines and Democratic Prospects; Restructuring for World Peace: At the Threshold of the 21st Century; Global Communication and World Politics: Domination, Development, and Discourse; Worlds Apart: Human Security and Global Governance; and Asian Peace: Security and Governance in the Asia Pacific Region.
- Henk ten Have is Professor and Chair of the Department of Ethics, Philosophy and History of Medicine in Nijmegen, The Netherlands. He is also coordinator of the European Commission Project "Palliative Care Ethics." He is Editor-in-Chief of the journal Medicine, Health Care and Philosophy; co-founder and secretary of the European Society for Philosophy of Medicine and Health Care, and Miembro Correspondiente en el Extranjero of the Real Academia Nacional de Medicina of Madrid. His recent publications include Medische Ethiek; Jeremy Bentham: Een quantumtheorie van de ethiek, and three books (co-edited): The Growth of Medical Knowledge; Consensus Formation in Healthcare Ethics; and Ownership of the Human Body.
- A. Raj Thiruvengadam is Assistant Professor in the Philosophy Department of Simmons College, Boston, where he focuses on philosophy of culture. Other areas of specialization are Asian philosophy, social and political philosophy, and philosophy of religion. He has cowritten a chapter in Ramsey Eric Ramsey's *The Long Path to Nearness*. His next book is titled *The Truths of Peace: Democracy and Contemporary Asian Philosophy.*
- Kirill Ole Thompson is a Professor in the Foreign Languages and Literature Department of National Taiwan University. His doctoral dissertation was "An Inquiry into the Formation of Chu Hsi's Moral Philosophy." His projects in progress are a translation with commentary of *Zhu zi xue tigang* (overview of Chu Hsi's learning) and the study of the socio-economic thought of Thorstein Veblen.
- Paul B. Thompson holds the rank of Distinguished Professor and teaches in the Department of Philosophy at Purdue University. He is also Director of Purdue's Center for Food Animal

- Productivity and Well Being. He has conducted research and teaching programs on controversial issues in the U.S. and global food system. His eight publications include Agricultural Ethics: Research, Teaching and Public Policy; Food Biotechnology in Ethical Perspective; and The Ethics of Aid and Trade: U.S. Food Policy, Foreign Competition and the Social Contract.
- James Tiles is Professor of Philosophy at the University of Hawai'i. His publications include Dewey: Critical Assessments in the four volume series The Arguments of the Philosophers, and An Introduction to Historical Epistemology: The Authority of Knowledge with Mary Tiles. He has just completed an introductory ethics text.
- Mary Tiles, Professor of Philosophy at the University of Hawai'i, is author of Bachelard: Science and Objectivity; The Philosophy of Set Theory: An Introduction to Cantor's Paradise; and Mathematics and the Image of Reason. Her recent research interests focus on the applied uses of mathematics, measurement, and modeling in both Chinese and European contexts.
- Jeffrey R. Timm is Chairman of the Religion Department at Wheaton College, Massachusetts. He recently published *Texts in Context: Traditional Hermeneutics in South Asia*. He is presently exploring Western modernity's challenge to traditional forms of Buddhist expression, and Buddhist responses to the problems generated by the commodifying and consumerist patterns of global market capitalism.
- Tu Wei-ming is Professor of Chinese History and Philosophy at Harvard University and Director of the Harvard-Yenching Institute. He is currently interpreting Confucian ethics as a spiritual resource for the emerging global community. He is author of Humanity and Self-Cultivation: An Essay in Confucian Thought; Centrality and Commonality: An Essay on Confucian Religiousness; Confucian Thought: Selfhood as Creative Transformation; and Way, Learning, and Politics: Essays on the Confucian Intellectual, as well as editor of The Living Tree; Confucian Traditions in East Asian Modernity; and Confucianism and Human Rights.
- Hans van Drongelen is a Calvinist Campus Chaplain at the University of Technology in Delft, The Netherlands. His concentration in the study of theology is on spirituality in modern society. He currently organizes workshops and conferences exploring spiritual issues in the engineering profession.
- Paul Varley, Professor Emeritus, Columbia University, is presently Sen Söshitsu XV Professor of Japanese Cultural History in the History Department of the University of Hawai'i. His publications include Japanese Culture; Warriors of Japan as Portrayed in the War Tales; and Tea in Japan: Essays on the History of Chanoyū (co-editor).
- Stephen Vaughn is a professor at the University of Wisconsin, Madison, where he has taught the history of communication since 1981. His most recent book is *Ronald Reagan in Hollywood: Movies and Politics* and he is now working on a history of new communication technologies and their impact on American society. He has also published more than 30 articles in scholarly journals.
- J. His book The Pacific Theater: Island Representations of World War II was awarded the Masayoshi Ohira Memorial Foundation prize.
- David B. Wong is the Harry Austryn Wolfson Professor of Philosophy at Brandeis University. He writes primarily in the fields of ethical theory, comparative ethics, and Chinese philosophy. He is the author of *Moral Relativity* and articles including "On Flourishing and Finding One's Identity in Community" and "Coping with Moral Conflict and Ambiguity."
- Ryuzo Yanagimachi is a Professor in the Department of Anatomy and Reproductive Biology, University of Hawai'i. In 1996 he received the International Prize of Biology for his continuous work in reproductive biology. In 1998 his international team of researchers amazed the scientific community with their successful cloning of mice. This cloning technique has provided scientists with a valuable tool for researching molecular processes dealing with embryo formation, cell differentiation, aging and disease.
- Guorong Yang is Professor and Chair of the Department of Philosophy at East China Normal University, Shanghai; the Director of the Academic Committee of Chinese Philosophy; and the Director of the International Society of Confucianism. He is currently Visiting Scholar at the Harvard-Yenching Institute. His publications include Reason and Values; Thinking towards Existence; and Scientism in Modern China.
- Ming-Bao Yue is an Associate Professor of Chinese at the University of Hawai'i. Her most recent publications include "Am I in That Name? Women's Writing as Cultural Translation in 1920s China" and "On Not Looking German: Ethnicity, Diaspora and the Politics of Vision."
- Hossein Ziai is currently Director of Iranian Studies, University of California, Los Angeles, where he has taught Iranian and Islamic studies since 1988. He has published several volumes and numerous articles on Islamic Philosophy. His books include Philosophy of Mathematics; Anvariyya (16th c. Persian commentary on Ilikmat al-Ishraq); Knowledge and Illumination; Shahrazuri's Commentary on the Philosophy of Illumination; The Book of Radiance; and The Ball and Polo Stick (with W. M. Thackston).
- Noam J. Zohar is a member of the Department of Philosophy, Bar Ilan University, Israel, where he teaches Moral and Political Philosophy, Rabbinic Thought, and courses in Applied Ethics and Halakha. He is also Director of the Graduate Program in Bioethics, a Fellow at the Shalom Hartman Institute, Jerusalem, and a Member of the Ethics Committee at Rabin Medical Center. He is currently a Faculty Fellow at the Center for Ethics and the Professions, Harvard University. His published works include Alternatives in Jewish Bioethics and the forthcoming The Jewish Political Tradition (co-edited).
