Family members who are outside the U.S. and will enter in O-3 status after the O-1 petition is approved do not need to file a Form I-539/I-539A. Dependents who will leave the U.S. before their current O-3 status expires also need not file a Form I-539/I-539A.

Form I-539 and I-539A: If the family members are currently in the U.S. and will change to/extend O-3 status, they must complete Form I-539/I-539A. Complete the Request to Include Form I-539 for Dependents if the O-1 employee is would like the Form I-539/I-539A application sent to USCIS with the H-1B petition.
