INTERVIEWS: Interviews will be scheduled upon receipt and confirmation of Candidate application.

Applicants who meet minimum qualifications will be contacted by the chair of the search committee to schedule an interview. Applicants who reside on-island will be asked to schedule an in-person interview while applicants who reside off-island will be asked to schedule an interview via Google Meet or Zoom.

Applicants must prepare for a 45 minute interview which will include a **10 minute** presentation prepared by the candidate and presented on a training initiative for Resident Assistants that is relevant to their position. Applicants must submit a copy of their presentation and it must include the Title, Abstract and Learning Outcomes of the presentation.

Applicants who complete the interview process will be notified of their candidacy status for the position via e-mail. A candidate deemed eligible for appointment will either be offered a position for the 2021-2022 academic year or placement in a pool of alternate candidates for the 2021-22 (AY).

Acceptance letters are due back from candidates within one week from the date of offer.
