3. Biographical/Historical Note

> Susan Chun Lee

Susan Chun was born in 1896 in P'yŏngyang, Korea. She was the youngest of three daughters and a son. Her older brother was reported to have been educated in Western medicine and a practicing medical doctor in Seoul.

Susan Chun graduated from Jinmyung Girls' (Elementary) School in Pyongan in July 1908 and entered Jinmyeong Girls' Middle School in Seoul. Upon completion of one year at Jinmyeong Middle School, Susan transferred to Ewha Hakdang in 1910. She graduated from Ewha (high school level) in March 1912. Upon her graduation from Ewah, she was married to K. S. Lyu (You K. Sung) in 1913/1914. Shortly after their marriage, Lyu was sent to America for education at Boston University, and after graduation he settled and established a business in Los Angeles, CA, under the name of 'K. S. Lyu & Co.' His business distributed general merchandise imported from China with headquarters in Shanghai and Nanjing, China. Susan Chun gave birth to her first daughter, Ok Hei Lyu (later Stella O.H. Lee) on August 12, 1914.

On February 3rd, 1916, Susan Chun received a Japanese passport in Seoul to go to Hawaii to meet her husband. On June 10, 1916, she sailed from Yokohama, Japan, on the Shinyo Maru (Ticket number 12133) with her two-year-old daughter Ok Hei. In Honolulu, she taught Korean language class at St. Luke's Episcopal Church. Sometime in 1917, her husband made a short trip to Hawaii, and Susan gave birth to her second daughter, Ock In Ryu (later Ellen O.I. Craig Choy) on June 1918.

On May 24, 1921, she divorced K. S. Lyu in Hawaii for the reason of desertion and non-support and married Henry Dongbin Lee. Susan C. Lee continued to teach Korean class and tried to promote Korean culture. Although it is not clear when and where Susan learned to play the Korean drum (*janggu*), she accompanied her daughters' dancing from the 1930s when multi-ethnic cultural programs were sponsored by the Honolulu Academy of Arts (predecessor of the Honolulu Art Museum).

Susan Chun Lee was an active member of the Korean Women's Relief Society and headed the Relief Society for several years in the 1940s. From March 1944, Susan was editor of the *Korean Pacific Weekly*. Although it is not known how long she kept her position, Susan was the first female editor of the *Weekly*. During the Korean War, she with many Relief Society members was busy greeting Korean naval ships at Honolulu Harbor. They served Korean food to the visiting naval cadets.

In early 1950s, Susan Shun Lee moved to Los Angeles with her daughter Dorothy. She died in Los Angeles on June 19, 1969 and she was laid to rest next to her husband at Diamond Head Memorial Park.

➤ Henry D.B. Lee

Henry Dongbin Lee (Dong Pin Yi, age 6) arrived in Honolulu on May 8, 1905 with his 31-year old father, Wook Tai Yi (Lee) Dong Bin Lee was enrolled at Mills School (the present Mid-Pacific Institute) and was one of the first group of youngster staying in the River Street campus dormitory in Honolulu. Sometime along the way, Henry moved to Hilo and attended Hilo Boarding School but transferred back to Mid-Pacific around 1917. Henry excelled at school and was Art Director of the Mid-Paicfic annual Ka Anuenue for 1917-1918. Henry graduated in 1918 and not long after graduation he got a job and was working when he got married.

Henry was an assistant chemist at the Waialua Sugar Company and maintained a financially comfortable living in the company's executive housing in Waialua. Henry had 6 children (3 boys and 3 girls) with Susan, in addition to Susan's 2 daughters from her previous marriage. The Lees attended Waialua Korean Methodist Church and Henry assisted Rev. Sa Yong Whang from 1927. From 1928 through 1931, Henry Lee took charge of ministering the Waialua church and from 1932 until 1938 he served as Director of Religions Activities. Along with her husband, Susan taught Korean classes at the church.

Henry Lee served as the basketball coach to the Korean team sponsored by the Waialua Recreation Council and the team won the championship in 1933, 1937 and 1938.

In 1939, Henry was transferred to Castle & Cooke, one of five major companies in Hawaii, and the family moved to Honolulu. Henry was then appointed as Sunday School Superintendent of the Korean Christian Church and his family attended KCC on Liliha Street.

Henry D. Lee died on March 10, 1947 and was buried at Diamond Head Memorial Park.

> Residences:

Susan Chun Lee and her husband, Henry D. Lee, as well as their children moved from Waialua, HI to Honolulu, HI in the late 1930's. They bought and lived in several different homes. On March 10, 1947, Henry D. Lee died. Family sold the property and bought another home on Kapiolani Blvd in the mid-1950's. She eventually sold the property and moved to Los Angeles, CA with her son Samuel and daughters, Dorothy and Rose. Between the mid 1950's to the late 1960's, in Los Angeles, CA, she lived in several different homes.

> Stella O.H. Lee

Born on August 12, 1915 – died on August 27, 2010, at age 95.

She was born in P'yŏngyang, Korea. On June 10, 1916, she sailed from Yokohama, Japan, on the Shinyo Maru to Hawaii with her mother Susan Chun Lee. She worked in Claims for Liberty Mutual Insurance Company from which she retired. She was a number of the Volunteers in Public Service to the Hawaii Courts program where she did volunteer work in the different offices of the Family Court and proceeded to receive numerous recognitions for the large number of hours, years and work she provided. In 1994, she was nominated for the 18th Annual first Lady's Outstanding Award for the work she did mastering the computer and in entering data for the Family Court's Juvenile Monetary Restitution Program. In 1995, she received from the Hawaii Supreme Court a plague in recognition of the five years of dedicated service for her work on the Juvenile Monetary restitution Program. She never married and was devoted to her family.

> Ellen O.I. Lee

Born on June 16, 1917 – died on May 5, 2008, at age 90.

She married Edward Doo Chun Choy and had one child, Timothy Young Chu Choy. They were later divorced. She worked for IBM and later the U.S. government and was assigned to Okinawa and Korea, where she was the secretary for General Walters, U.S. 8th Army in Seoul after the Korean War. She later remarried Colonel James Terry Craig. After his retirement, they took up residence first in California and then in Las Vegas, NV. He died, and she continued to reside in Las Vegas.

> Dorothy Aihe Lee

Born on April 28, 1926 – died on October 31, 2009, at age 83.

She was trained by her mother, Susan Chun Lee, to perform Korean dance at the Honolulu Academy of Arts Korean programs and also on the Honolulu Korean Chamber of Commerce Aloha Week floats. She was a member of the Korean Christian Church Choir and later served as the church organist. In the 1950s, she accompanied Susan C. Lee when she moved to Los Angeles, California, where she worked for the U.S. Immigration Department from which she retired as an Immigration Officer. She was a member of the First Christian Church of Santa Monica. When she became legally blind due to diabetes, she moved back to Honolulu in 2001 and lived with her sister Stella in Makiki until her death.

> Rose A. Lee

Born on December 16, 1933 – died on February 15, 1986, at age 53.

Like her sister, she was also trained by her mother, Susan Chun Lee, to perform Korean dance at the Honolulu Academy of Arts Korean programs. She graduated from the University of Hawaii, Music Department. She accompanied Susan C. Lee when she moved to California in the 1950s, and then she later moved to New York, where she died.

> Samuel C. Lee

Born on March 9, 1923 – died on September 4, 1982, at age 59.

He graduated from the University of Hawaii, served in the U.S. Army, and moved to California, where he worked as an engineer with McDonald Douglas Air. He was married but had no children. He died while on a vacation in Mexico.

> Timothy Young Chu Choy

Born on February 4, 1942.

He was born of Ellen O.I. Lee and Edward Doo Chun Choy. Educated at Pacific University, Forest Grove, OR, and the Pennsylvania State University, where he earned his master's and Ph.D. In 1969, he joined the faculty at Minnesota State University Moorhead, Moorhead, MN where he was a senior tenured full

professor. His last three years there he served as the university communications officer to the president. He retired in December 1998 and returned to Hawaii, where he served as administrative project assistant to the director at the Honolulu Academy of Arts.

The Susan Chun Lee Papers includes materials generally related to Korean community in Hawaii, her contributions to Korea, personal items and documents, and personal history. There are publications, photographs, certificates, awards, phonograph records, letters, correspondences, newspaper clippings, memorial obituary card, passport, and tickets. The collection constitutes an important source for the Korean Independence Movement, the Korean War, Korean music and dance, Koreans and Korean language education, early Korean immigration to Hawaii, and Korean international organizations.

The Family Member's papers consist of papers from Susan's family. This collection constitutes an important source for Korean immigration to the United Stateand descendants of immigrants. It consists of the personal materials of Susan's family, especially her second husband Henry D.B. Lee, the daughters Stella O.H Lee and Ellen O.I. Lee, and her grandson Timothy. It also includes documents on donation and funding by Susan's family to several institutions.

Henry D.B. Lee Papers includes materials dating since his relocation to Hawaii and placement in Mills Boarding School in 1905. There are trophies, publications, certificates, photographs, correspondence, and licenses.

Stella O.H. Lee Papers includes materials of her school days, her career at Liberty Mutual, and as a volunteer serving the courts after retirement. There are letters, cards, articles, correspondence, photographs, receipts, publications, objects, pamphlets, and booklets.

Ellen O. I. Lee Papers includes materials related to her school days and her career at IBM, the U.S. Government and the U.S. Army, as well as materials from her second husband, Colonel James Terry Craig. It contains a lot of correspondence, especially correspondence with her secondhusband, and diary & notes as well as newspaper clippings, handwriting, publications, files, documents, ID, receipts, leaflets, and scrapbook.

Timothy Y. C. Choy Papers contains materials related to his school days and his career as a professor at Moorhead State University, and work with the Honolulu Academy of Arts (HAA). This includes a lot of papers and correspondence that worked with the HAA, and postcards received by Timothy. There are also graduation diplomas, pamphlets, booklets, photographs, correspondence, folders, articles, cards, ID, leaflets, objects, newspaper clippings, certificates, scrapbook.

9.2. Biographical note

Henry Dongbin Lee (Dong Pin Yi, age 6) arrived in Honolulu on May 8, 1905 with his 31-year old father, Wook Tai Yi (Lee) Dong Bin Lee was enrolled at Mills School (the present Mid-Pacific Institute) and was one of the first group of youngster staying in the River Street campus dormitory in Honolulu. Sometime along the way, Henry moved to Hilo and attended Hilo Boarding School but transferred back to Mid-Pacific around 1917. Henry excelled at school and was Art Director of the Mid-Paicfic annual Ka Anuenue for 1917-1918. Henry graduated in 1918 and not long after graduation he got a job and was working when he got married.

Henry was an assistant chemist at the Waialua Sugar Company and maintained a financially comfortable living in the company's executive housing in Waialua. Henry had 6 children (3 boys and 3 girls) with Susan, in addition to Susan's 2 daughters from her previous marriage. The Lees attended Waialua Korean Methodist Church and Henry assisted Rev. Sa Yong Whang from 1927. From 1928 through 1931, Henry Lee took charge of ministering the Waialua church and from 1932 until 1938 he served as Director of Religions Activities. Along with her husband, Susan taught Korean classes at the church.

Henry Lee served as the basketball coach to the Korean team sponsored by the Waialua Recreation Council and the team won the championship in 1933, 1937 and 1938.

In 1939, Henry was transferred to Castle & Cooke, one of five major companies in Hawaii, and the family moved to Honolulu. Henry was then appointed as Sunday School Superintendent of the Korean Christian Church and his family attended KCC on Liliha Street.

Henry D. Lee died on March 10, 1947 and was buried at Diamond Head Memorial Park.

Henry D.B. Lee Papers consist of his personal items and documents, including certificates, diploma, photograph, and correspondence for contribution to Korean-American Council. Also, it contains two missionary publications. Some oversized items are located in the Susan Chun Lee Family box 5.

Stella O.H. Lee was born on August 12, 1915 – died on August 27, 2010, at age 95. She was born in P'yŏngyang, Korea. On June 10, 1916, she sailed from Yokohama, Japan, on the Shinyo Maru to Hawaii with her mother Susan Chun Lee. She worked in Claims for Liberty Mutual Insurance Company from which she retired. She was a number of the Volunteers in Public Service to the Hawaii Courts program where she did volunteer work in the different offices of the Family Court and proceeded to receive numerous recognitions for the large number of hours, years and work she provided. In 1994, she was nominated for the 18th Annual first Lady's Outstanding Award for the work she did mastering the computer and in entering data for the Family Court's Juvenile Monetary Restitution Program. In 1995, she received from the Hawaii Supreme Court a plague in recognition of the five years of dedicated service for her work on the Juvenile Monetary restitution Program. She never married and was devoted to her family.

11.2. Biographical note

Ellen O.I. Craig Choy was born on June 16, 1917 – died on May 5, 2008, at age 90. She married Edward Doo Chun Choy and had one child, Timothy Young Chu Choy. They were later divorced. She worked for IBM and later the U.S. government and was assigned to Okinawa and Korea, where she was the secretary for General Walters, U.S. 8th Army in Seoul after the Korean War. She later remarried Colonel James Terry Craig. After his retirement, they took up residence first in California and then in Las Vegas, NV. He died, and she continued to reside in Las Vegas.

11.3. Scope and Content Note

Ellen O.I. Craig Choy Papers includes materials related to her school days and her career at IBM, the US.S Government and the US.S Army, as well as materials from her second husband, Colonel James Terry Craig. It contains a lot of correspondences, especially with Col. 12.2. Biographical note

Dorothy Aihe Lee was born on April 28, 1926 – died on October 31, 2009, at age 83. She was trained by her mother, Susan Chun Lee, to perform Korean dance at the Honolulu Academy of Arts Korean programs and on the Honolulu Korean Chamber of Commerce Aloha Week floats. She was a member of the Korean Christian Church Choir and later served as the church organist. In the 1950s, she accompanied Susan C. Lee when she moved to Los Angeles, California, where she worked for the U.S. Immigration Department from which she retired as an Immigration Officer. She was a member of the First Christian Church of Santa Monica. When she became legally blind due to diabetes, she moved back to Honolulu in 2001 and lived with her sister Stella in Makiki until her death.
