One final entry was made in August. He died from malnutrition some time before Wake was surrendered to the United States on September 4, 1945.
- The translator's complete more literal translation was edited and excerpted by an unnamed American commander of Wake, some time after October 9, 1945. The commander's prefatory note explains this, and also identifies the translator as his interpreter, "34 year old American born Japanese named Kitagagwa Kitao, whom we called 'Fred' for short."
