Instructions for Completing the MIX Financial Certification Form

Section I: Applicant Information - For students to complete

Section II: Family or Sponsor's Affidavit of Support - For sponsors to complete. Refer to the table below for further instructions.

Name of sponsor	Enter the name of the person or organization funding your studies. If you are funding yourself, enter your own name.
Relationship to applicant	Specify the relationship, such as "Father," "Mother," or "Self" if you are self-funding.
Amount of support in U.S. \$	Enter an amount equal to or greater than the required amount on page 2 of the form. If you have multiple sponsors, submit an additional form for each.
Signature	You may sign if you are self-funding; otherwise, your sponsor must sign.

Section III: Bank Verification for Visa Purposes - For the bank to fill out to provide proof of funding. In some cases, Section III may be left blank. See below for more information.

- If you provide scanned copies of any Acceptable Financial Documents (listed below) showing sufficient funds, you do not need to complete Section III. If the documents are not in English, include a translation.
- If you cannot provide any Acceptable Financial Documents, have your bank or sponsor's bank fill out Section III to confirm that you or your sponsor have access to the required funds. The bank should sign and provide a seal or stamp in Section III, if possible.

Acceptable Financial Documents:

- Personal funds: Bank statement(s)** in the applicant's name showing the account balance.
- Parent or sponsor's funds: Bank statement(s)** in the sponsor's name showing the account balance.
- Other institutional support/award letters: Official letter showing the amount and length of support.
- Loan certificates/letters: Must specify the applicant's or sponsor's name and the approved loan amount. Conditional loan approvals are accepted only if contingent upon receiving your I-20 or DS-2019. Loan applications are not accepted as proof of funding.

** Bank/Financial statements must:

- Clearly show the financial institution's name, account holder's name, account balance, and type of currency;
- Be dated within the past 60 days (older statements will not be accepted);
- Be translated into English (especially names) unofficial translations are accepted;
- Show that assets/funds are liquid and can be converted to cash.

Once you have completed the MIX Financial Certification Form, submit a scanned copy to the Mānoa International Exchange (MIX) Office following the guidelines listed on the How to Apply page for <u>undergraduates</u> or <u>postgraduates</u>.
