# Call for Papers

## Roadmap to a Healthier and More Equitable Hawai'i: Solutions to Root Causes at the Intersections of Chronic Disease and Covid-19

### Special Issue of the *Hawai'i Journal of Health and Social Welfare*

As policy-makers, researchers, and news media have revealed, the Covid-19 pandemic highlights fractures in our health systems, social structures, and public policy. Those groups most at risk of infection, hospitalization, and death from Covid-19 are often those most vulnerable in our society: older adults, racial/ethnic minorities, people with limited incomes, those experiencing food insecurity and crowded housing, *etc.* All of these groups experience more chronic conditions than the general population. For some groups including Native Hawaiians, Other Pacific Islanders, Filipinos, and those without insurance or using Medicaid, chronic conditions often occur earlier in life, are more severe, and are less well managed.

Chronic conditions are one of the most pronounced risk factors for poor outcomes, if infected with Covid-19. Recent research from Centers for Disease Control and Prevention reported that three-quarters of decedents of Covid-19 had an underlying medical condition. The three most common conditions were cardiovascular disease, diabetes, and chronic kidney disease, which were present in 60%, 40%, and 21%, respectively, of deaths due to Covid-19. These conditions, especially diabetes, were even more common among young and working age adults who succumbed to the virus.

Many of the underlying determinants for Covid-19 and chronic conditions are the same and these determinants reflect social marginalization and power differentials. Thus, addressing these underlying determinants would reduce susceptibility to Covid-19, hospitalization, and death due to the virus, as well as the health and economic burdens of chronic conditions. Even in the context of Covid-19, chronic conditions remain the leading causes of death and disability in our state and nationally.

Fresh perspectives and innovative solutions are clearly needed to address the underlying inequities and injustices that Covid-19 has so clearly illuminated. It is time for transformative change that protects all of our community and in doing so, assures greater resilience to future health threats. This special issue seeks contributions offering diverse perspectives, proposals, and solutions for Hawai'i that aim to address and change the underlying sources of illness and inequity in our communities, with a specific focus on chronic disease in the context of Covid-19. In particular, we are looking for submissions that make contributions towards systems, environmental, and policy changes, as well as those that discuss or target root causes of health disparities in chronic disease.
