 - 3. Jettison racial hierarchy was a theme commission members liked
 - 4. Four subcommittees: Research, Education, Listening, Policy
 - a) Senator Ward submitted interest to Policy as 1st Choice and Listening as 2nd choice

- 3. Language was focus for the low enrollment programs
- 4. Public Health
 - a) Provost was very supportive of this program
 - b) When personnel was discussed, they always said faculty and staff
- 5. Discussion was to keep those programs but somehow roll them into the college and not be listed as a low enrollment program

C. Senator Dionne

- 1. Computer Science and Physics
 - a) Bruno really loves Physics
 - b) Bruno did indicate change is going to happen, it has to happen
 - c) It was an undertone of sternness but with a nice tone

D. Senator Nakashima

- 1. Law and JABSOM Quantitative Health Sciences
 - a) Law, recommended stop out for two programs
 - (1) Directors of the programs, dean and associate dean were present
 - (2) There was a lot of back and forth, Law talked about how the LLM program was actually bringing in a lot more money (LLM was considered for a cut)
 - (a) With this new info, Bruno said he can look into the program further
 - (3) Bruno said he would support one program and not the other
